See* (1966) and subsequent family law precedent, the legally traceable amount of separate property is conclusively determined to be **\$59923.48**.

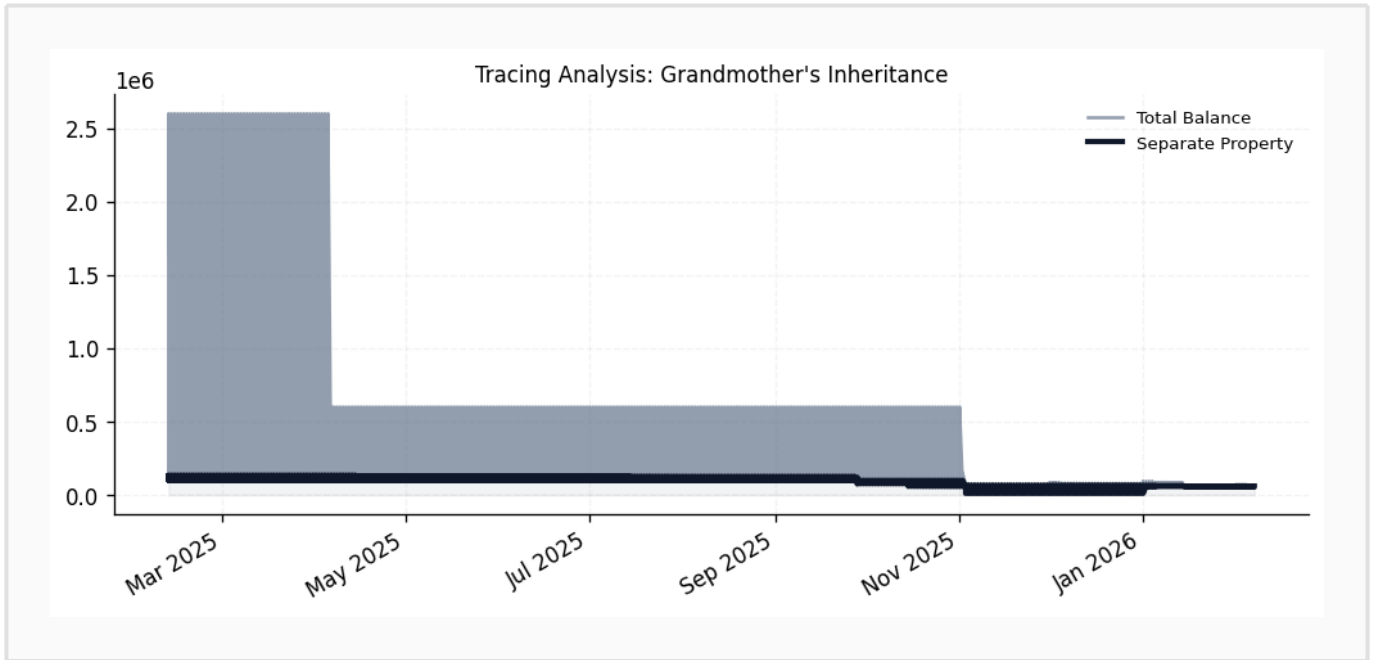


Chart depicts daily account balance (blue) vs. traceable separate property claim (orange) over analysis period
